~NOTICE TO VOTERS~

You must complete all parts of this application. If your ballot is to be mailed other than to your home address please list the mailing address where indicated. Also, include either a phone number or e-mail address where you can be reached in case we have any problem with the mailing of your ballot.

Your application must be received in our office on or before the Thursday preceding Election Day in order to vote by mail.

Upon receipt of your completed application and as ballots become available, a ballot will be mailed to you along with the necessary instructions.

An incomplete application cannot be processed. If you have questions regarding this voting process, please contact the Election Department by calling 815-288-3309 or e-mail to election@countyoflee.org.

Any voter admitted to a hospital, nursing home or rehabilitation center not more than 14 days before an election shall be entitled to personal delivery of an absentee ballot subject to certain conditions. Unless you are a voter admitted to a hospital, nursing home or rehabilitation center not more than 14 days before an election, or a resident of a soldiers' and sailors' home, only you or your spouse, parent, child, sibling or a company licensed by Illinois as a motor carrier engaged in the business of making deliveries may, in person, take your ballot and ballot card envelope for deposit into the mail.
